Four residencies are awarded annually through an international call for submissions. "Writers in Residence" are awarded a rent and utility free stay in the "Kerouac House" along with a food stipend. In exchange, writers participated in community events and readings, interviews and teaching within the community. At the end of their stay, writers reach out to the community through a farewell reading held in the house, free of charge, followed with a Q & A regarding the creative process. The Kerouac Project also participated in festivals and literary events with the goal of increasing awareness of Jack Kerouac, the writer and the Kerouac House as a literary landmark in the central Florida area.
